This Quick Reference Guide provides information on where to look for CWPP information specific to the needs of individual homeowners in Grant Creek.

Grant Creek CWPP 2024

Pages 74-76 describe the **Four Focus Areas** for hazardous fuel treatment around housing in the Grant Creek Planning Area. Identify the focus area where your home is located to determine potential risk to your property. Your identified focus area represents your Neighborhood Risk Zone. *All homes in the Grant Creek Planning Area have exposure to the threat of wildfire.*

Pages 77-78 describe the **Home Ignition Zone (HIZ)** and the importance of each homeowner in preparing their zone *prior* to a wildfire event. Every home's HIZ is different, requiring different strategies for reducing risk. Local emergency and fire agencies that do free HIZ inspections of homes in Grant Creek are listed. *The most important action a homeowner can take to reduce risk is to have a free HIZ inspection completed to determine where problems might exist on the exterior of their home and outbuildings that need to be corrected to reduce risk.*

Pages 79-81 describe **potential hazardous fuels projects** in each of the four focus areas. Some of these projects can be completed by individual homeowners at minimal cost. Others will require working with neighbors to reduce hazards.

Pages 81-82 describe how **grant funding** can pay for work for both individual homeowners and for larger, more costly projects involving multiple neighbors.

Pages 82-84 describe **Wildfire Evacuation Planning** in the Grant Creek Planning Area and what needs to be included in a site-specific plan for residents to have better information that will increase their situational awareness and personal safety.
